Application of **RAMAH DAY CAMP RESIDENCE HALL** of 303 Christian Herald Road Valley Cottage, NY, for a modification of the special permit use condition previously granted to remove the restriction on date and time of operations and allow the camp, residence hall and ancillary facilities to be utilized year round. The premises affected are situate at 303-403 & 320 Christian Herald Road, Valley Cottage, NY in an R-160 zoning district and further identified on the Clarkstown Tax Roll as Map 59.12-1-11 & 59.16-1-2 f/k/a 136-C-10.01 & 7.

**APPEAL #4133** 

The Applicant, RAMAH DAY CAMP, having been denied a building permit by the Building Inspector and having been previously granted a special permit use condition, seek a modification of the special permit use condition previously granted to remove the restriction on date and time of operations and allow the camp, residence hall and ancillary facilities to be utilized year round and the Board of Appeals having held public hearings on October 29, 2018, November 19, 2018, January 14, 2019 and February 11, 2019.

On October 29, 2018, November 19, 2018 the following members of the Board were present and constituted a quorum; Kevin F. Hobbs, Chair, Mark Maraia, Brian Metcalf, Edward Mistretta, and Thomas Heim, Darcy Casteleiro, and Ryan Sheridan

On January 14, 2019 the following members of the Board were present and constituted a quorum; Mr. Kevin Hobbs, Chairman, Mr. Brian Metcalf, Ms. Darcy Casteleiro, Mr. Edward Mistretta, Mr. Thomas Heim and Mr. Ryan Sheridan. Mr. Mark Maraia was absent.

On February 11, 2019 the following members of the Board were present and constituted a quorum; Mr. Kevin Hobbs, Chairman, Mr. Brian Metcalf, Ms. Darcy Casteleiro, Mr. Thomas Heim, Mr. Mark Maraia and Mr. Ryan Sheridan. Mr. Edward Mistretta was absent.

Deputy Town Leslie Kahn and Deputy Building Inspector Lawrence Kay were in attendance on October 29, 2018, November 19, 2018, January 14, 2019 and February 11, 2019.

Now upon said hearing and the evidence presented, it is hereby found and determined:

### **FINDINGS OF FACT**

FIRST: Applicant, JEWISH THEOLOGICAL SEMINARY OF AMERICA, owns the property which is the subject of this appeal.

SECOND: The Applicant's property is located at 303-403 & 320 Christian Herald Road, Valley Cottage, NY and further identified on the Clarkstown Tax Roll as Map 59.12-1-11 & 59.16-1-2 f/k/a 136-C-10.01 & 7.

THIRD: The Applicant seeks a modification of the special permit condition previously granted to remove the restriction on date and time of operations to allow the residence hall/dormitory and ancillary facilities to be utilized year round. The current special permit allows the dormitory to be utilized from April 1 to November 1 to house Camp staff and to allow use of the Camp for weekend retreats and for synagogue family and Jewish youth group functions during the periods in the Spring and Fall before and following the regular camp season.

- FIFTH: Kevin F. Hobbs motioned for the Board to adopt a negative declaration as this application is considered an unlisted action under SEQRA and will not result in any significant adverse environmental impact which was seconded and carried unanimously.

SIXTH: Ira Emanuel, attorney for the applicant stated that Ramah Day Camp currently has a special permit to use and operate the camp from April 1 to November 1 for weekend retreats and for synagogue family and Jewish youth group functions. Mr. Emanuel stated the applicant is now requesting a modification to the existing special permit to allow the use of the camp for retreats and for synagogue and Jewish youth groups and similar functions throughout the year in addition to the regular summer day camp use. Mr. Emanuel provided a history of the site. The site has been used as a camp or a children's home continuously since 1894. Mr. Emanuel acknowledged in 2013 there was a fire which led to the discovery that students from Rockland Country Day School (RCDS) were residing in the dormitory. This was not permitted by the camp's special permit. The camp then requested a special permit modification (Appeal #4106) to allow Rockland Country Day School to continue to rent the premises from the Applicant to house their international students, which was denied by the ZBA. That use has ceased and will not be continued. Mr. Emanuel stated this appeal is a less intensive use than what was proposed in Appeal #4106. He described Ramah as a religious organization with a mission to educate and stimulate Jewish thought and foster Jewish culture in youth and adults in a less formal environment. Year round activities would allow Ramah to continue their mission for those who can't avail themselves of summer camp activities. Year round programs held by the National Ramah Commission camps include Passover Seders, religious retreats, retreats for women and father/son, teen weekends, interfaith activities to combat anti-Semitism as well as other "life cycle events". Mr. Emanuel stated the proposed use of the buildings is to continue the use of the camp from April 1 to November 1 and to expand the use of the dormitory and ancillary facilities to service those individuals occupying the dorm for year round use. The ancillary facilities include the kitchen, dining room, synagogue and recreational facilities. The overnight occupancy of the dormitory would be limited to 72. Only the dormitory and ancillary facilities are to be used year round. Currently, programs occurring at Camp Ramah in the spring and fall are limited in time, usually weekends and limited to one group. Each group would have the whole camp to themselves. There will be no increase in size or occupancy of the other buildings on the campus. Ramah would comply with all applicable regulations and codes. The applicant is not proposing any new construction or parking lots. The traffic generated by this proposal will be small and the majority of attendees will be transported via bus. Mr. Emanuel stated it would be hard to quantify the number of people attending events but not staying overnight. There is a reciprocal agreement
